We are pleased to inform you that the Clark County School District Food Service Department will be implementing a program at your child's school called the Community Eligibility Provision (CEP).

What does this mean for you and your child(ren) attending this school?

All enrolled students at CEP schools are eligible to receive a healthy breakfast and lunch every day for <u>no</u> <u>charge</u> during the 2020-2021 school year. *No further action is required of you.* Your child(ren) will be able to participate in these meal programs without having to pay a fee or submit a meal application. Only breakfast and lunch meals will be free of charge; the purchase of a la carte items will require payment.
